I hereby agree, for myself and/or for a minor under the age of eighteen for whom I am signing, to indemnify, defend and hold the entities named above harmless from and against any and all claims, liabilities, losses and damages, costs, expenses (including attorney’s fees), judgements and penalties arising out of any of my, and or said minors, acts or omissions to act.
